- \* Nominee has faced some challenge(s), either personal challenges or some evidence of demonstrating uncommon determination, broken some barriers or overcome obstacles in life;
- \* Nominee has demonstrated a commitment to either community activities, professional organizations or non-profit work, which evidences a belief in contributing to others.
